- "Applicants and travel agents are requested not to bind two or more passports with a stapler to avoid getting it damaged. Instead, you may bind them together using rubber bands."
- Personal appearance by appointment, with biometrics.

#### **Processing Time:**

- Applications shall be lodged no more than three months before the intended visit starts.
- Applications shall be decided on within 10 to 15 working days after the embassy scheduled appearance.
- Please be guided by the agency policy: No agent will accompany the applicant/s at the embassy.
- Grandson travel and tours will only schedule the biometrics appointment of the applicant
