Processing Fee: PHP 2,500

- The required documents have to be submitted with the visa application (no fax or e-mail to the Embassy is accepted).
- The Embassy of Turkey reserves the right to ask for additional documents and/or for a personal interview as well as to verify the content and truth of the documentation presented.
- The application should be submitted at the local Visa Facilitation.
- Please note as per instructions, personal Bank statements (last 6 months) with stamp/signature of Bank in original need to be submitted on A4 size only.

### **Processing Time:**

- Applications shall be lodged no more than three months before the start of the intended visit.
- Applications shall be decided on within 10 20 working days after the date of lodging.
